## Near-Month Natural Gas Futures Prices (NYMEX) through Nov 09

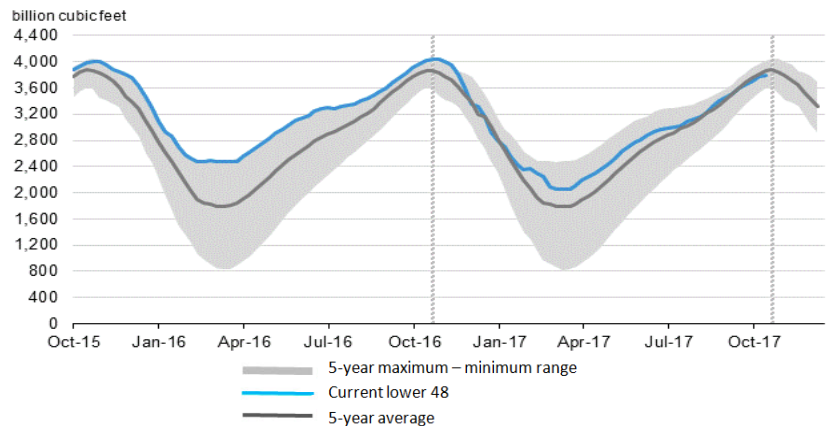

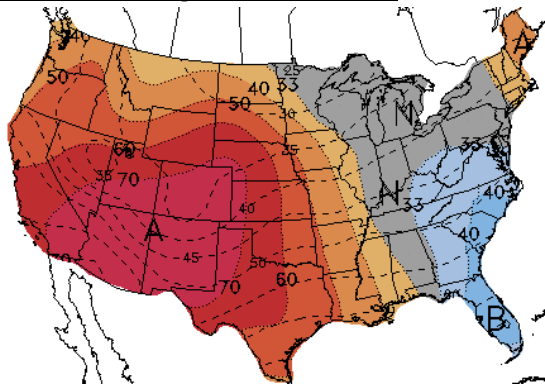

## Working Gas in Storage Compared to 5-Year Range



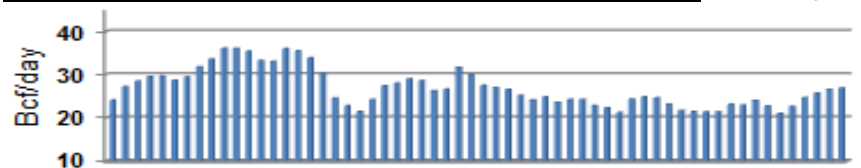
## Temperature Forecast Nov 17 through Nov 23, 2017
